OUR REQUIREMENTS FOR BOARDING PETS WITH US:

- 1.) **All pets must be current** on the following vaccinations PRIOR to boarding. **Proof of vaccinations is required if they were administered at a vet clinic other than our own.**

Canines -- Bordetella (every 6 months), Rabies, DA2PPV and Parvovirus, and K9 Influenza vaccines.
Felines -- Rabies and FVRCP vaccines.
- 2.) A yearly negative fecal test is required, and all pets must be free of external parasites (i.e ticks, fleas, etc.), or they will be treated at the owner's expense.
- 3.) Kiamichi Veterinary Clinic (KVC) has the owner's permission to treat a life threatening condition or emergency without his/her prior consent, which may require the use of anesthesia.
- 4.) If a sedative or anesthetic is necessary for treatment or handling, KVC has the owner's permission to administer such medication without verbal confirmation (this signed form gives the owner's consent).
- 5.) If the doctor and staff of KVC deem a non-emergency treatment that is necessary for the well-being of the pet while boarding with us (such as, but not limited to, a tooth extraction or heartworm treatment) the owner will be contacted by phone to explain the necessary treatment and to obtain their verbal approval. If the owner cannot be reached after several attempts by KVC, and the client does not contact us within 48 hours, we will proceed with the treatment.
- 6.) Pets may be picked up Monday through Friday from 8AM until 4:30PM (but after 9AM if a bath is requested), and Saturday from 8AM until 11:30AM; Sunday and holiday pick-up is at the staff's discretion and per their availability). Owner also understands that KVC staff may not be available to answer phone calls outside of designated business hours.
- 7.) Pet owner also understands that KVC takes every precaution to not only prevent illnesses and pests (such as ticks and fleas) from infecting our boarding area, but also to keep every animal safe that is in our care. Therefore, owner accepts that KVC is not responsible for any ailment or injury that the pet might acquire after it has left our care.
- 8.) Pet owner also understands that they are responsible for picking-up their pet after boarding, and that if they (or another previously mentioned designated person) does not do so within 10 days, (or fails to maintain contact with KVC), that KVC will consider the pet abandoned, and reserves the right to re-home it.

I have read and consent to KVC's boarding requirements and policies as they have been explained to me above, and I understand that I can talk with the veterinarian and staff if I have any questions or concerns. I also agree to pay for boarding and all charges for any additional services or veterinary treatment that may become necessary during the time my pet is in the care of KVC.
